Since 2019, I have been actively engaged in multiple EONS initiatives, including the Young Cancer Nurse Group, Communication Working Group, Scientific Program, ECND, and ECCN Working Groups, where I have contributed to various projects and research efforts in collaboration with the EONS team. This experience has given me a strong foundation in research leadership, collaboration, and strategic planning, aligning with EONS's mission to drive excellence in oncology nursing through evidence-based practice.


