OVERVIEW

ECLIPTIC - ENHANCHING EU ONCOLOGY NURSING PRACTICE FOR CLINICAL EXCELLENCE

ECLIPTIC is an European Project funded under the Erasmus+ Programme aimed to develop an innovative VET programme for European cancer nurses with the following **OBJECTIVES:**

- Enhance the clinical skills and patient care through intensive immersion in up-to-date oncology practices, equip the participant nurses with advanced knowledge and techniques to provide high-quality patient care
- Increase nurses specialist practice skills such as studying new practical procedures, including assessment and safety protocols, effective communication techniques, complex symptom management, nursing research methodologies, and addressing psychosocial consequences of cancer therapies thanks to simulation clinics
- Increase clinical leadership skills of nurses by providing networking sessions for participants to reflect on their role in clinical bed site leadership within the context of cancer nursing
